Cheaper To Insure Mixed Breeds!

Did you know that it is not only cheaper to buy health insurance for cross-breeds but they qualify for longer terms of According to a protection? major British pet insurance company report "A survey by the (insurance co) found almost 40% of pedigree pet policy holders will make a claim on their insurance compared to just over 20% of cross-breed David Pickett, pet owners." insurance manager Sainsbury Bank (UK) notes that "While it is imperative all dogs adequately cats are insured, our experience is that pedigree owners are more

likely to call on their pet insurance for illness and disease than owners crossbreeds because their animals are more likely to suffer certain hereditary illnesses." Another factor is size as it is cheaper to insure a terrier than a Labrador. The website also states purebred can be covered through age 6 while a crossbreed can be covered through the age of 8.

Evidently, the insurance actuaries found statistical proof that mixed breeds are, on the whole, healthier than purebreds.
